1. Northern Sunrise Assessment Contract

4. Subdivisions 01-SD-16 and 02-SD-16

34.22.03.16 Moved by Councillor Mercier that the subdivision application to subdivide a 14.60 ha (36.10 ac) farmstead separation from an unsubdivided quarter section SW 19-77-5-W6M be APPROVED subject to the following conditions:

- 1. That the applicant/owner dedicate a 5.0 m wide road right-of-way by caveat along the balance of the subject lot adjacent to Range Road 60 and Township Road 773 for future road widening, pursuant to Section 661 of the Municipal Government Act;
- 2. That the applicant/owner enter into a development agreement with the Municipal District of Spirit River No. 133 to include, but not be limited to, the upgrading of the access approaches to the proposed lot and the balance, if required;
- 3. That the applicant/owner provide easements and/or rights-of-way in accordance with utility company requirements; and
- 4. That the applicant/owner pay all outstanding property taxes pursuant to Section 654(1)(d) of the Municipal Government Act prior to the endorsement of the plan of subdivision, or arrangements made which are satisfactory to the Municipal District of Spirit River No. 133.

35.22.03.16 Moved by Councillor Garrow that subject to a variance being granted to the parcel size requirement under Sec. 11.1.2(a)(ii) of the LUB, it is recommended that the subdivision application to subdivide a 6.1 ha (15.0 ac) farmstead separation from an unsubdivided quarter section NE 19-77-5-W6M be APPROVED subject to the following conditions:

- 1. That the applicant/owner dedicate a 5.0 m wide road right-of-way by caveat along the balance of the subject lot adjacent to Range Road 55 and Township Road 774 for future road widening, pursuant to Section 661 of the Municipal Government Act;
- 2. That the applicant/owner enter into a development agreement with the Municipal District of Spirit River No. 133 to include, but not be limited to, the upgrading of the access approaches to the proposed lot and the balance, if required:
- 3. That the applicant/owner provide easements and/or rights-of-way in accordance with utility company requirements; and
- 4. That the applicant/owner pay all outstanding property taxes pursuant to Section 654(1)(d) of the Municipal Government Act prior to the endorsement of the plan of subdivision, or arrangements made which are satisfactory to the Municipal District of Spirit River No. 133.
