The purpose of this Land Use Bylaw amendment is to rezone a 13 ac portion of NW 9 78 5 W6M from Agriculture (A) District to Country Residential 1 (CR1) District. The purpose of the amendment is to facilitate the subdivision of one additional lots off of a previously subdivided parcel for residential lot.
