**BEING A BYLAW TO AMEND BYLAW 03-2009 THE LAND USE BYLAW OF THE  
MUNICIPAL DISTRICT OF SPIRIT RIVER #133**

**WHEREAS** the Council of the Municipal District of Spirit River #133, in the Province of Alberta has adopted A Land Use Bylaw 03-2009, and

**WHEREAS** the Council has the authority under the provisions of the Municipal Government Act, R.S.A. 2000, Chapter M-26 Revisions and Consolidation of Bylaws, Revision authorized, Section 63-2(h) with amendments thereto, to make amendments to its Land Use Bylaw,

**WHEREAS** the Council of the Municipal District of Spirit River #133 deems it desirable to amend the Land Use Bylaw No. 03-2009; now

**THEREFORE**, the Council of the Municipal District of Spirit River #133, duly assembled, **HEREBY ENACTS AS FOLLOWS:**


1. **THAT** the land use district classification for the **Southwest Twenty-five (25) Township Seventy-eight (78) Range Five (5) West of the Sixth Meridian (W6M)** be amended from **Agriculture (A)** to **Country Residential 1 (CR1) District** as illustrated on Schedule "A" attached hereto.
2. **THAT** this bylaw shall come into force and take effect upon the Third and Final Reading thereof

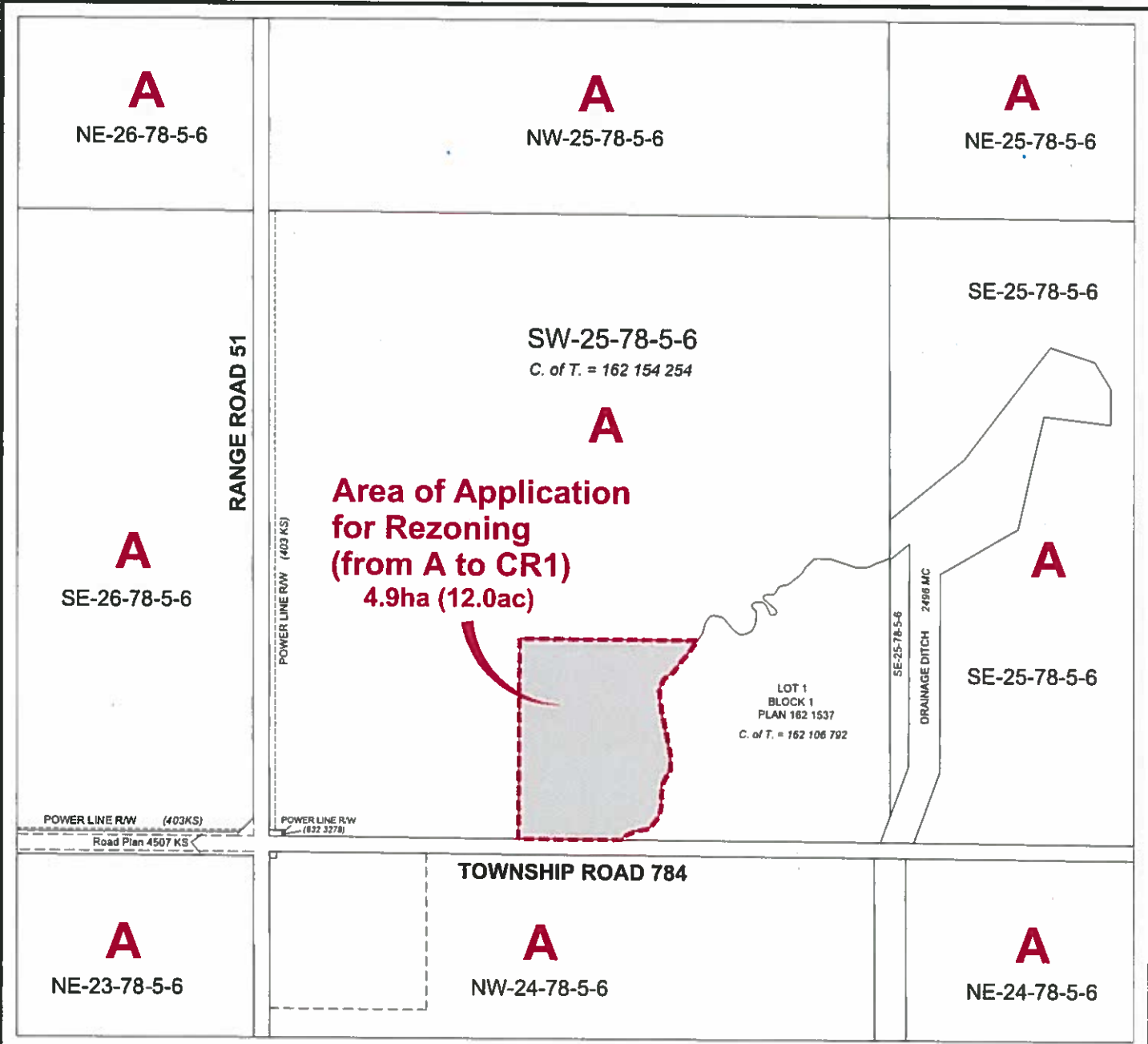
