SECURITY CAMERA REBATE

The Municipal District of Spirit River #133 continues to offer the Security Camera Rebate to our residents. We know the program is successful with “eyes” through our area capturing images of illegal activities as residents are able to report unlawful hunting, dumping, and THEFT to the authorities. We encourage you to report suspicious activities you observe or capture on your security cameras.

IMPORTANT PENALTY INFORMATION

Penalty charges on outstanding current taxes will be levied as follows:

- 2% penalty on September 16, 2021
- 2% penalty on October 15, 2021
- 2% penalty on November 15, 2021
- 2% penalty on December 15, 2021
- An additional 10% penalty will be calculated on all balances outstanding for 2021 and previous years on January 1, 2022.
